- Your organisation or business must be fully inclusive of the LGBTQ+ community.
- Please note: We do not provide onsite WIFI.
- Please note: We do not provide onsite power.
- Please note: The following items are not permitted: petrol generators, smoke machines, amplified music, strobe lighting, confetti, balloons.
- Please note: There is no vehicle access to your allocated stall.
- Groups are advised to drop of any items required to exhibit at the (Check-In Hub) items can then be walked onto site with the assistance of our volunteers.
- Please note: Due to limited space, there is no onsite parking, MKPF will allocate bays outside the event for (Community Space) exhibiters.
- A site map with detailed information on accessing the event, along with our pre-event pack will be sent one week prior.
- Groups will be expected to provide a list of names of exhibitors attending on the day.
- Please be ready for opening at 12:00 PM on the event day and no packing away of any sort until 5:45 PM.
- Please note face painting, hair braiding or glitter activities are not permitted.
- Stalls are expected to adhere to the highest standards of presentation; all non-display items should always be tidied out of view.
- Stalls must use plain or branded tablecloths.
- Rainbow bunting will be on display prior to your arrival. You will not need to bring your own.
- No children or pets allowed.
- All rubbish must be removed from site before, during, and after the event in the provided skips. You are responsible for your own waste.
- We do not allow the collection of cash or data on behalf of charities; this includes offering a service or product in return for a donation or asking people to sign up to direct debits etc.
- Community Stalls are not permitted to transfer their stall or include any other group without permission from the organiser (only approved groups are invited to exhibit at this event).
- Community Stalls are not permitted to sell goods.
- All groups must have their own Public Liability Insurance; this must always cover you and your volunteers sufficiently during the event during set up/pack down. The signing of this booking form confirms that you have the required insurance in place.
- You are required to provide us with a minimum of £5 million Public Liability Insurance.



Terms and conditions.

- Groups are responsible for ensuring their displays and props do not obstruct or endanger in any way the public or any other group stallholder and should be aware of their own and others' health and safety. The event organiser cannot be held responsible for any type of damage, injury, or loss, however caused.
- MK Pride Festival reserves the right to allocate Community Stalls at its own discretion. No organisation may seek or gain admission without a completion of this form. Allocation decisions are final and may not be contested.
- Community Stalls will not require the use of a gazebo, our stalls operate similarly to the Rainbow Market, in which is a set fixture space.
- Groups wishing to provide activities whilst exhibiting must have provided details in this form. Any unapproved activity will result in immediate stall closure.
- MK Pride Festival is committed to ensuring we are as environmentally friendly as possible, and as such expect our stalls holders to operate with a similar approach. Goods provided, such as giveaways etc, should always put environmental sustainability at their forefront.
